#### **Processing of Outstanding Applications**

All adult applicants are scheduled for interviews. In April 805 interviews were scheduled and applicants attended in 462 cases (attendance rate of 57%)

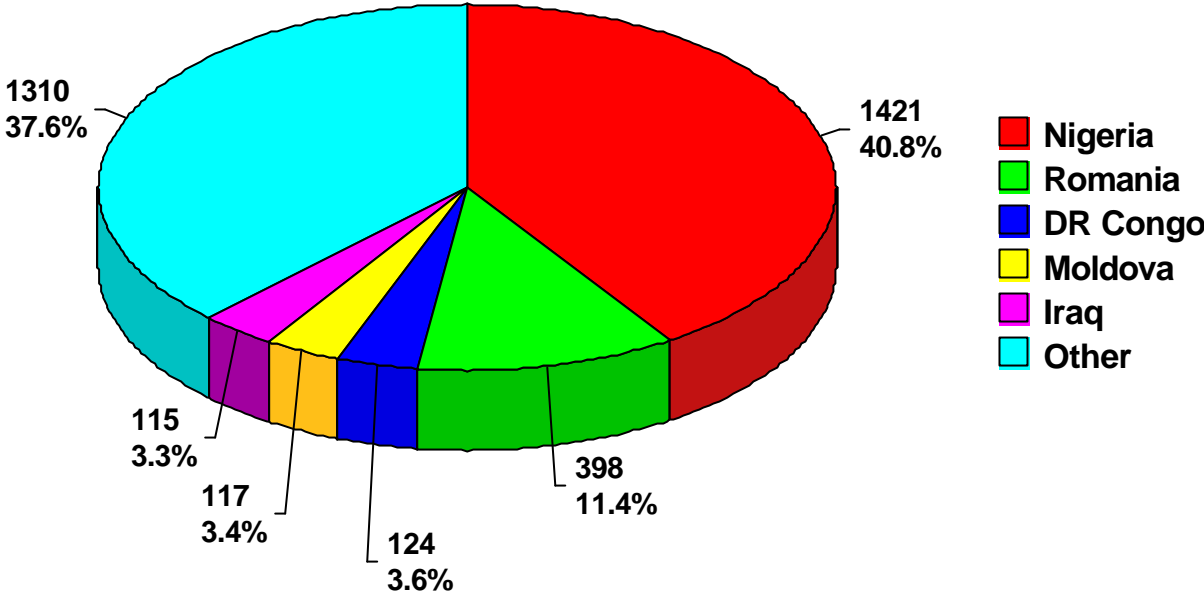
