#### **Processing of Outstanding Applications**

All adult applicants are scheduled for interview. In May 808 interviews were scheduled. Excluding interviews postponed by ORAC, applicants attended in 71% of cases.

#### **Decisions overturned**

These are manifestly unfounded cases overturned at appeal and cases which were overturned following Judicial Review.

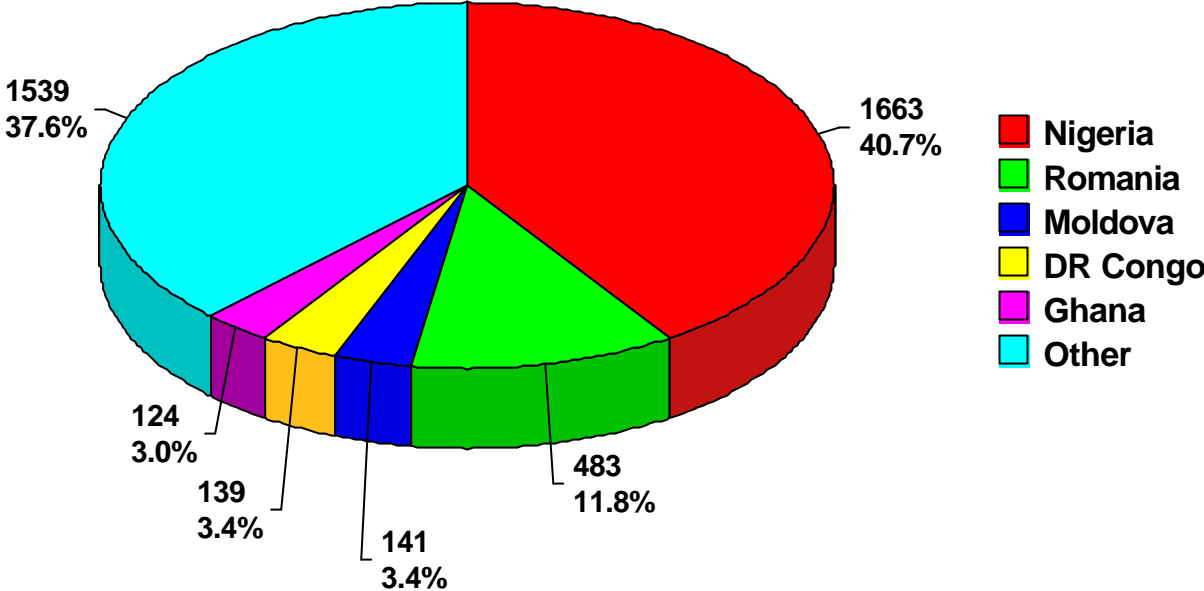
