*Two 1997 case which cannot yet be finalised are included in the 1998 figure and an additional two have been added to the 1998 recommendations. All other pre 1998 cases have been processed.

Processing of Outstanding Applications

All adult applicants are scheduled for interviews. In September 1587 interviews were scheduled and applicants attended in 482 cases (attendance rate of 30%)

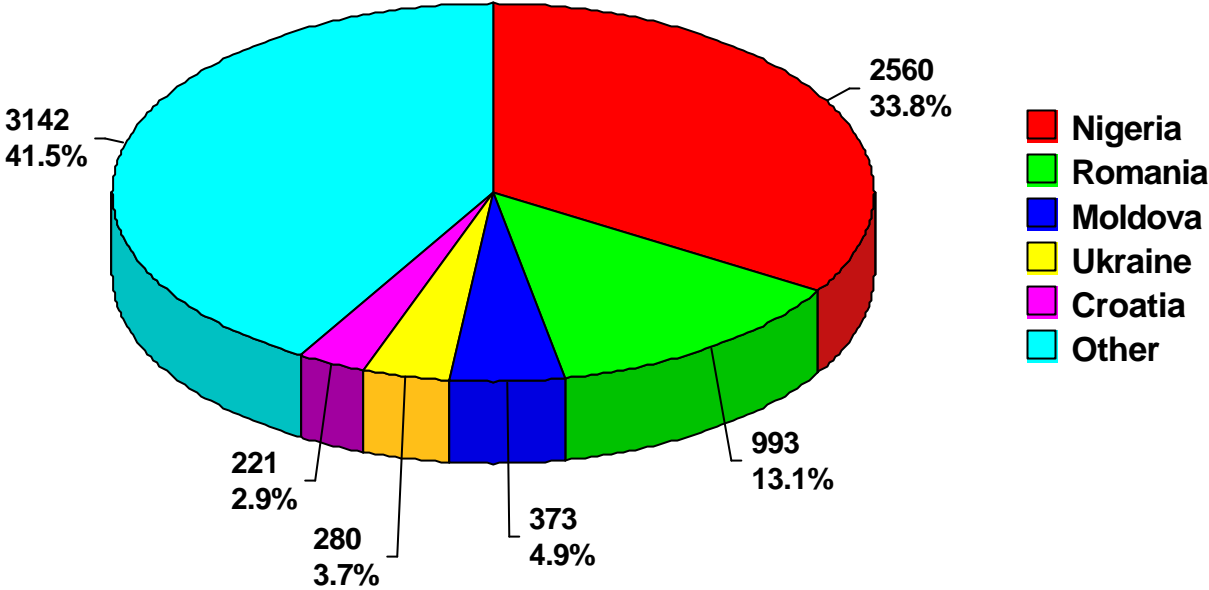
