#### **Processing of Outstanding Applications**

All adult applicants are scheduled for interviews. In September 1043 interviews were scheduled and applicants attended in 476 cases (attendance rate of 46%)

These are manifestly unfounded cases overturned at appeal and cases which were overturned following Judicial Review.

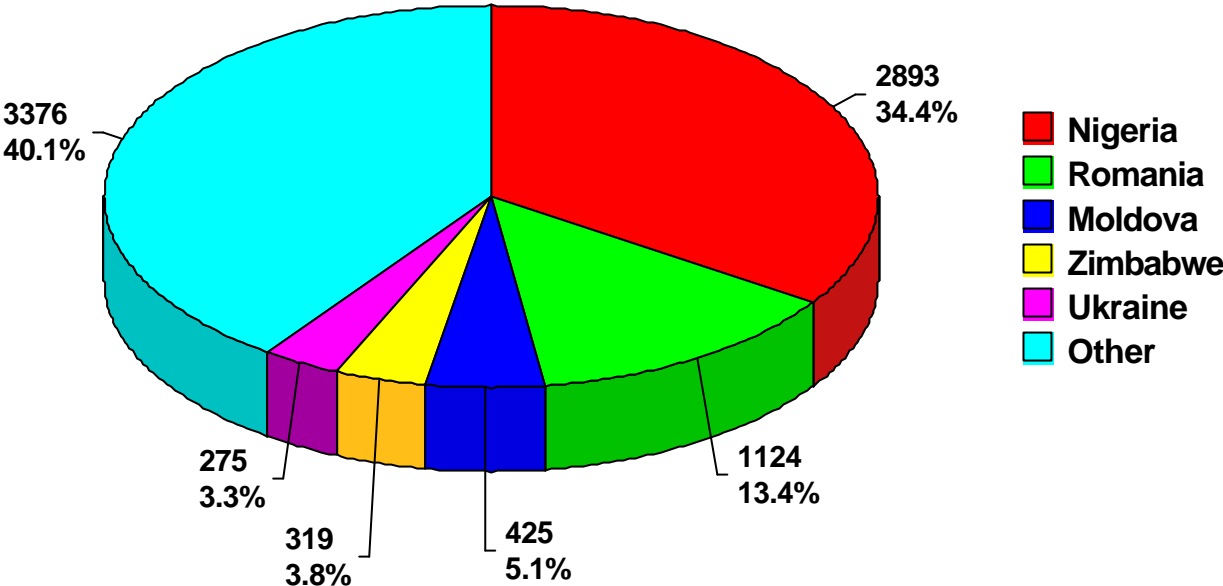
