#### **Processing of Outstanding Applications**

All adult applicants are scheduled for interviews. In November 1115 interviews were scheduled and applicants attended in 504 cases (attendance rate of 45%)

These are manifestly unfounded cases overturned at appeal and cases which were overturned following Judicial Review.

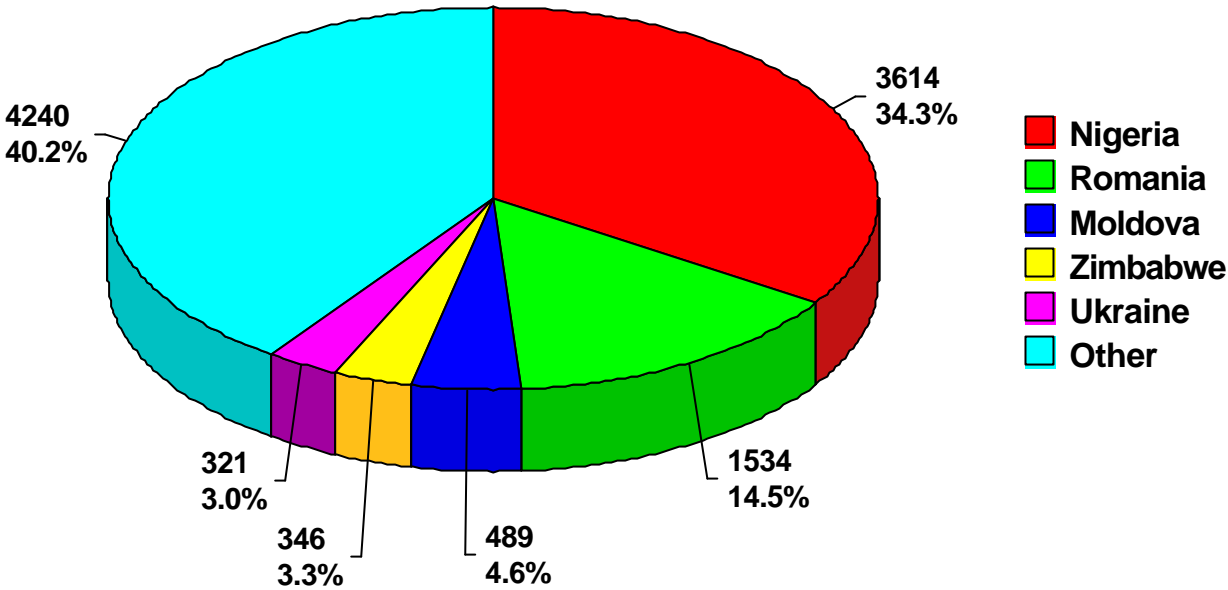
